IRC §280E prevents businesses that are engaged in "drug trafficking," including marijuana, from taking regular business deductions. §280E forces cannabis businesses to use specific accounting methods, makes them more likely to be audited and significantly raises the potential tax liability for cannabis operators. On December 20, 2018, the President signed the Agriculture Improvement Act of 2018 ("Farm Bill"). This law is groundbreaking because it removes hemp (containing less than 0.3% THC) from the purview of the Controlled Substances Act. The FDA will now have an expanded role in regulating these products and hemp – including CBD – will be subject to the same regulations and requirements as other non-cannabis FDA-regulated products.

As the industry navigates and creates this "new normal" regulatory environment, it is more important than ever to have experienced legal advisors on your team. Similarly, marijuana's Schedule 1 status is not relevant to the protection of trade secrets or copyrights either. Each of these types of intellectual property can be used to protect your company.
